

# **“CROATIA DAYS 3v3 FUTSAL TOURNAMENT” ATHLETIC WAIVER AND RELEASE OF LIABILITY**

## **YOU MUST READ THIS DOCUMENT BEFORE SIGNING IT**

In consideration of being allowed to participate in any way in the “Croatia Days 3v3 Futsal Tournament” (the “Program”) hosted by United Croats of Canada - King Tomislav Branch (“UCC”), I, [PRINT NAME] \_\_\_\_\_, acknowledge, understand, and agree as follows:

- 1) I understand that there is a significant risk of injury, including, without limitation, permanent disability or death, from the activities involved in this Program.
- 2) I knowingly and freely assume all such risk of injury and death, both known and unknown, whether arising from my participation in the Program, the negligence of the Releasees (as hereinafter defined) or others, or otherwise, and I assume full responsibility for my assumption of said risk.
- 3) I willingly agree to comply with the stated and customary terms and conditions for my participation in the Program.
- 4) If I observe any unusual hazard during my attendance at, or participation in, the Program, I will remove myself from participation and bring said hazard to the attention of the nearest official immediately.
- 5) On my own behalf and on behalf of my heirs, assigns, personal representatives and next of kin, I HEREBY RELEASE AND HOLD HARMLESS:
  - a) UCC, its directors, officers, officials, agents, representatives, and employees;
  - b) other participants in the Program;
  - c) the Program’s sponsors, advertisers, and any other persons affiliated in any way with the Program; and
  - d) any owners, lessors, and occupants of premises at which the Program takes place

(collectively, the “Releasees”), with respect to any and all injury, disability, death, or loss or damage to my person or property, whether arising from the negligence of the Releasees or otherwise, to the fullest extent permitted by law.

6) I FURTHER UNDERSTAND AND FREELY AGREE THAT BY SIGNING THIS WAIVER, I AM GIVING UP MY RIGHT TO SUE THE RELEASEES, AND TO OTHERWISE OBTAIN COMPENSATION FROM THEM, EVEN IF I AM INJURED OR KILLED AS A RESULT OF THEIR NEGLIGENCE (OR THE NEGLIGENCE OF ANY OF THEM).

**I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.**
